
3. The Patent Holder is unwilling to grant licenses in accordance with provisions of either 1 or 2 above.

Rather, "free of charge" refers to the issue of monetary compensation; *i.e.*, that the Patent Holder will not seek any monetary compensation as part of the licensing arrangement (whether such compensation is called a royalty, a one-time licensing fee, etc.).
